**OLD BUSINESS:**

**Ordinance No. 4.13-16 – Erecting 45 MPH Speed Limit Signs on Willow Road:** **MOTION** by Cebula, 2<sup>nd</sup> by Miller to sign Ordinance No. 4.13-16 that was passed at the May Town Board meeting pertaining to erecting 45 MPH speed limit signs on Willow Road. **Request From David Hintz for Building Permit:** Mr. Hintz met with Ralph Moegenburg, the Town of Bevent Zoning Permit Administrator. Mr. Moegenburg stated that Mr. Hintz's lot is a non-conforming lot and that Mr. Hintz is requesting information on obtaining a permit to either remodel his current residential structure by increasing the footage of the building along with possible roof and fascial work, or replace the current building. Moegenburg said he would discuss the situation with the Town Board at the June Town Board meeting. **MOTION** by Miller, 2<sup>nd</sup> by Wanta to deny Mr. Hintz's request for a zoning permit per Mr. Moegenburg's inspection and recommendation. **The Town of Bevent to Sponsor Bevent Lions Park Project:** The Bevent Lions Club applied for a grant thru Marathon County Environmental Impact Fund. Up to 50% of the total project's cost is reimbursable thru the fund. The funds would be used in the purchase of the land located at 6412 Village Lane and construction of a picnic area/community gathering shelter/storage facility. The funding request is for \$50,000.00. Local units of government shall be required to guarantee or underwrite the amount of local funds pledged by applicants in order to qualify for EIF distribution. **MOTION** by Cebula, 2<sup>nd</sup> by Wanta to sponsor the Bevent Lions park project.
