The Town of Bevent will pay for half of the surveying bill as discussed at the Town of Sharon Town Board meeting on April 12, 2016.

<u>Wash Out Problems on Store Lane</u>: Store Lane is a steep road and when we get a significant amount of rain the gravel shoulders wash out onto the roadway, which is blacktopped. The following quotes were received on fixing the problem: (starting even with the back of the dock by PRM)
