This position was previously a salaried position of \$1,650 annually, with compensation paid quarterly. Resolution No. 2015-01 was amended in January 2017 to include \$20 per month reimbursement for cell phone. MOTION by Wanta, 2nd by Cebula to change the compensation for the Zoning Permit Administrator position from a per permit to a salaried compensation beginning July 1, 2017. He will be paid quarterly with reimbursement for cell phone only. No other expenses or mileage will be reimbursable. Cebula-yes, Gruna-yes, Wanta-yes. CARRIED.
