Fire/Ambulance District: The district has 2 ambulances with 1 being housed for \$50 per month at the Reid Town Hall. Chairman Dallman set a deadline of November 1 to find a different place to house the ambulance. The Town of Reid has set a special meeting to discuss with the townspeople the possibility of building a new building and leasing it to the district. If the Town of Reid residents are in favor of this, then quotes will be accepted for the new building.

Roadwork: Blacktopping will be started around the middle to end of August, culverts will be installed as soon as the water subsides, and gravel/granite has been delivered on various town roads
