**NEW BUSINESS:**

**Appoint/Reappoint Poll Workers for the 2018-2019 Election Cycle:** **MOTION** by Cebula, 2<sup>nd</sup> by Gruna to reappoint Therese Kluck, Ruby Pepowski, Marcia Tepp, Marlene Gross, Adeline Domask, Elaine Filtz, Elsie Wanta, and Phyllis Kasprak and appoint Austin Kluck as poll workers for the 2018-2019 election cycle. **45 MPH Speed Limit Sign on South Birch Road:** The intersection between Shantytown Drive and South Birch Road is controlled by stop signs on both Shantytown Drive and South Birch Road. South Birch Road starts at County Road C in the Town of Bevent and continues into the Town of Sharon as Bentley Road and ends at County Road Y. This road is currently 55 MPH. Cebula asked the Marathon County Sheriff's Department to patrol South Birch Road whenever possible, hoping this will deter some of the violators from not stopping at the stop sign on South Birch Road. **MOTION** by Gruna, 2<sup>nd</sup> by Wanta to leave the speed limit on South Birch Road at 55 MPH and monitor the situation. **Broadband Update:** Rick Letto, General Manager of the Amherst Telephone Company informed every one of the upcoming application process for grants being awarded for expanding broadband services to the Town of Bevent. Mr. Letto is requesting businesses and residents send him letters of support so he can include them with the application. Grants may possibly be awarded in March of 2018.

**Public/Private Partnership Agreement with Amherst Telephone Company:** As part of the PSC Grant Application, one area that is required is a public/private partnership. **MOTION** by Gruna, 2<sup>nd</sup> by Wanta for the Town of Bevent to sign a document entering into this Public/Private Partnership with Amherst Telephone Company for the purpose of expanding Broadband Services to the Town of Bevent through a PSC Broadband Expansion Grant.
