OLD BUSINESS:

Broadband Update: Rick Letto, Representative from the Amherst Telephone Company said that the PSC should start awarding grants around the middle of April. If the Town of Bevent receives a grant, construction would possibly begin in July or August of 2018, and if needed, finish up in Spring of 2019. There would be approximately 18 miles of fiber optic lines laid.

<u>Annual Fee Agreement with Pietz, VanderWaal, Stacker & Rottier</u>: The firm of Pietz, VanderWaal, Stacker & Rottier currently represents the Town in legal matters. **MOTION** by Wanta, 2nd by Gruna to sign the contract with the proposed terms. Cebula-yes, Gruna-yes, Wanta-yes. **CARRIED**.

Discussion of Adopting a Subdivision Ordinance: Cebula contacted Lee Tournie, the Towns attorney and discussed the pros and cons of a subdivision ordinance. Lee mentioned that the Town has a lot of outdated ordinances and should consider updating them. The Town Board will look into updating the Town Ordinances.
