## **Reports:**

<u>Zoning Permit Administrator</u>: Moegenburg reported 3 permits issued since last meeting <u>Broadband Update</u>: Rick Letto from the Amherst Telephone Company updated everyone and everything is progressing as scheduled. The plan is to be splicing and testing in January of 2019.

## OLD BUSINESS:

<u>Sign Ordinance No. 4.14-18 Pertaining to Renaming Town Highways</u>. Action was taken at the October Town Board meeting. The Town Board signed the Ordinance.

**Resolution No. 2018-01 to Borrow Funds:** A motion passed at the October Town Board meeting to purchase a 2018 Caterpillar front end loader. Financing will be secured from the Community First Bank in Stevens Point. The loan amount will be for \$161,000.00 at an interest rate of 3.85% with a 5 year term. **MOTION** by Wanta, 2<sup>nd</sup> by Cebula to approve and sign Resolution No. 2018-01 to secure financing to purchase a 2018 Caterpillar front end loader. ## **NEW BUSINESS:**

**Resolution No. 2018-02 to Exceed Allowable Town Tax Levy:** The Department of Revenue sets the allowable tax levy for municipalities. The Town is allowed to raise their tax levy at the rate of new construction without resolutions or exceed the tax levy limit with resolutions. The rate of new construction for 2017 was 1.033 percent. The tax levy for 2017 was \$128,321. Without a resolution the 2018 tax levy would be \$129,509. MOTION by Gruna, 2<sup>nd</sup> by Wanta to approve and sign Resolution No. 2018-02 for the Town Board to propose exceeding the levy limits. Cebula-yes, Gruna-yes, Wanta-yes. **CARRIED**. A 12 percent increase over the allowable levy limit would increase the town levy by \$15,541.08 for a total town tax levy of \$145,050.08. The Town electors set the Town tax levy, therefore a resolution will need to be passed by the electors at the elector meeting scheduled for Monday, November 26, 2018 approving the Town Board resolution.
