**OLD BUSINESS:**

**Adoption of Section 10-Land Division Ordinance With Amendments:** **MOTION** by Lemke, 2<sup>nd</sup> by Wanta to accept the Planning Commission's recommendation to adopt the amended Section 10-Land Division Ordinance of the Code of Ordinances.
