<u>**Culvert Inventory Services</u>**: Towns are required by the WisDOT to inventory all culverts/ small bridges spanning 6' to 20' by the end of 2024. **MOTION** by Lemke, 2nd by Wanta to contract with Delmore Consulting to do the inventory. Cebula-yes, Wanta-yes, Lemke-yes. **CARRIED**. The town will be billed \$100 per culvert/small bridge by Delmore Consulting and the town will be reimbursed by WisDot \$100 per culvert/small bridge.</u>

<u>Agricultural Road Improvement Program (ARIP)</u>: The 2023-2025 state budget created a one-time \$150 million pilot program for the improvement of roads used by the agriculture industry. ARIP is a reimbursement program, which may pay up to a maximum of 90% of eligible project costs. The application deadline for the first \$50 million is April 5, 2024. WisDOT will announce a second grant application period later this year for the remaining \$100 million. Because the application period did not open up until early February, the Town of Bevent will not be pursuing this program until fall of 2024. Richard Wierzba volunteered to contact producers on Yellow Birch Road to submit applications for the program for the fall application period.
