**OLD BUSINESS:**

**Town Comprehensive Plan:** **MOTION** by Wanta, 2<sup>nd</sup> by Cebula to not pursue a comprehensive plan for the Town at this time. Cebula-yes, Gruna-yes, Wanta-yes. **CARRIED.**

**Update on County Line Drive Winter Driving Conditions:** Cebula talked to several Town of Bevent residents as well as Town of Sharon residents. They were satisfied with the maintenance of the road this past winter and understood the challenges the snow plow operators face in such treacherous conditions. The Town Board will keep an eye on all roads in the Township. **NOTE:** Three of the Rosholt School bus drivers that pick up students in the Town of Bevent sent the Town of Bevent snow plow drivers a thank you card which read:

Thanks for the great job this winter. We (3 of Rosholt School Bus Drivers) could count on Bevent to be the first in the area to have their roads cleared.

**Discussion on Allowing ATV/UTV's to Travel on Town Roads:** More discussion was held on the subject. Patti Olinski, VP of the Spirit Valley Rider ATV Club in Tomahawk answered questions about ATV/UTV travel on roads. More discussion will be held at the July Town Board meeting.

**Road Work on Canopy Lane:** Canopy Lane has been surveyed. It is a 3 rod road (49.5 feet wide). The Town part-time equipment operators will do most of the work on Canopy Lane. Roadwork will consist of installing a new culvert, cutting brush, removing trees, moving rocks, seeding the ditch, etc. Meverdeen Excavating or Tony's Landscaping will be contacted to do the bulldozer work. Ladick will be contacted to haul granite on the road. Tony Karner from Tony's Landscaping presented the Town with a bill for cutting down his trees, excavating stumps and moving his rock which was in the reconstruction area. No written contract was signed authorizing Mr. Karner to do any work on Canopy Lane. A verbal statement was made by Cebula suggesting Mr. Karner can cut down 2 trees and keep the wood, otherwise the town employees will cut the trees down. **MOTION** by Cebula, 2<sup>nd</sup> by Gruna for Mr. Karner not to do anymore work on Canopy Lane, unless he is contracted by the Town of Bevent. Cebula-yes, Gruna-yes, Wanta-yes. **CARRIED.**
