**Emergency Medical Responders:** Ron Yenter checked into the cost of allergic reaction medication for anaphylactic shock for EMR's to carry. A nasal spray would be approximately \$800 per dose, an epipen is approximately \$700 per dose and a vial to draw with a syringe is \$50 for the cost of the vial. The medical director for the HAFAAD does not recommend the vial option. As of now the EMR's do not carry any of these items in their emergency packs.
