**Update on 2025 Road Work:** The portion of the road that was pulverized earlier in the year on Leather Camp Drive has been blacktopped and American Asphalt will shoulder soon. Ice Age Lane has been pulverized and road base has been applied and will be blacktopped in 2026.

**NEW BUSINESS:**
